RQYS AMENITIES:

RQYS Reception is available from 7am to 8pm daily.

RQYS Hospitality operates from 7am to late daily. The trading hours are as follows:

The fuel dock is operational 24 hours, 7 days a week. A credit or eftpos card is required to use the fuel dock, and assistance can be provided during business hours by contacting the Marina office.

Diesel and Premium Unleaded (95) are available. Bowsers are available both on water, as well as on land to fuel cars/trailer boats/ jerry cans etc.

Camping amenities are available to campers 24hrs, 7 days a week with the use of a PIN Code (available at Reception) There is an abundance of showers and bathrooms available underneath the RQYS Marina & Sailing office, and a coin operated laundry facility available in the Slipway building (refer to the attached map).

Supermarkets are conveniently located approximately one kilometre north of the Squadron, on the corner of Royal Esplanade and Cambridge Parade. This shopping district include a supermarket, post office, bakery, chemist, as well as a chandlery. More information can be provided by the RQYS reception staff as required.

Boat ramps are available on squadron grounds dependant on designation during regattas.

Two ramps are available onsite; the most common ramp is utilised primarily as the main access for dinghy classes and can be used for the launching and retrieving of trailer boats. The Eastern ramp or the 'all tide ramp' may be used for launching and retrieval of trailerable boats. However, if you intend to use this ramp be aware it is accessed through the marina hardstand area and launching and retrieving should not interfere with work within this area.

Even though the ramps are cleaned regularly, we ask that you should always exercise caution as they can be slippery. On busier days, a ramp marshal may control traffic on the middle ramp and please listen to any direction given by them so that you can access the ramp in the safest way possible. A free wash down facility is available on the concrete apron at the head of each ramp and we ask that boats are not washed down on the lawn.

Two public boat ramps are available in the Manly Marina. The closest is accessible via the large public carpark immediately outside the Squadron grounds. The second is located on the northern end of the marina, accessed by turning off the Esplanade onto Fairlead Crescent. See the RQYS Reception staff for further assistance.

DEED OF INDEMNITY & WAIVER

This Deed is made the day as appears in Schedule 1.

BETWEEN: ROYAL QUEENSLAND YACHT SQUADRON LIMITED of Royal Esplanade, Manly, Brisbane including its directors, officers, officials, employees, members, or other authorised persons collectively called ("RQYS")

AND: The party named in Schedule 1. ("Camper")

BACKGROUND

- RQYS is the registered owner of the Land and the Camper has asked RQYS for permission to camp upon the land for an agreed period as named in Schedule 1 which RQYS has agreed to subject to the Camper executing this Indemnity and Waiver.

The parties covenant and declare as follows:

The Camper must only camp in areas designated as camp/van sites and must pay the Fee or fees to the RQYS as directed.

The Camper must comply at all times and in all respects with all or any directions given to the Camper by the RQYS including but not limited to parking and standing of motor vehicles, boats, rigging, trailers and other equipment.

The Camper must only use the shower and toilet facilities as designated by the RQYS.

In granting the use of the Land by the RQYS the Camper agrees to indemnify RQYS against all damages, costs, expense and losses of any kind, including but not limited to personal injuries and (including legal fees on an indemnity basis) which RQYS may suffer as a result of any breach or anything done by or not done by the Camper, or a breach of this Deed.

The camper acknowledges that they will comply with the Code of Conduct of the Royal Queensland Yacht Squadron whilst on its premises.

Camping Code of Conduct

1. GENERAL:

- 1.1 All campers must abide by all RQYS policies whilst on premises. This includes (but is not limited to) the RQYS Grounds Access Policy, RQYS Parking Policy, RQYS Code of Conduct etc.
These documents are able to be viewed at <https://www.rqys.com.au/policiesanddocuments/>.
- 1.2 Campers may only establish their campsite on grounds designated by RQYS management.
- 1.3 Campsites are to be kept clean from litter and all rubbish is to be collected and appropriately discarded prior to departure from RQYS grounds.
- 1.4 Open fires are not permitted.
- 1.5 Campsites must be set up in a safe manner, and any potential safety hazards in the campgrounds or surrounding areas are to be reported to RQYS management immediately.
- 1.6 Access to RQYS Grounds is strictly limited to individual booked in with the RQYS Camping Booking form. Any visitors or guests are restricted to the Clubhouse facilities and must sign in appropriately. Any unauthorised access will be deemed a breach of security and will result in further action being taken.

2. MARINA:

- 2.1 The RQYS Marina is home to several livaboards, and is located in close proximity to residences on the mainland. Campers are required to show respect for RQYS members and neighbours at all times.
- 2.2 Noise should be kept to a minimum. Please use discretion when playing music and radios, and quiet hours are considered to be from 9pm to 7am daily.
- 2.3 Fishing within the Marina is strictly prohibited.
- 2.4 Riding of bicycles/scooters/skateboards etc. on the marina structure is strictly prohibited.
- 2.5 Campers are requested to stay on the mainland, avoiding the marina jetties, out of respect of the privacy of the Squadron's members.

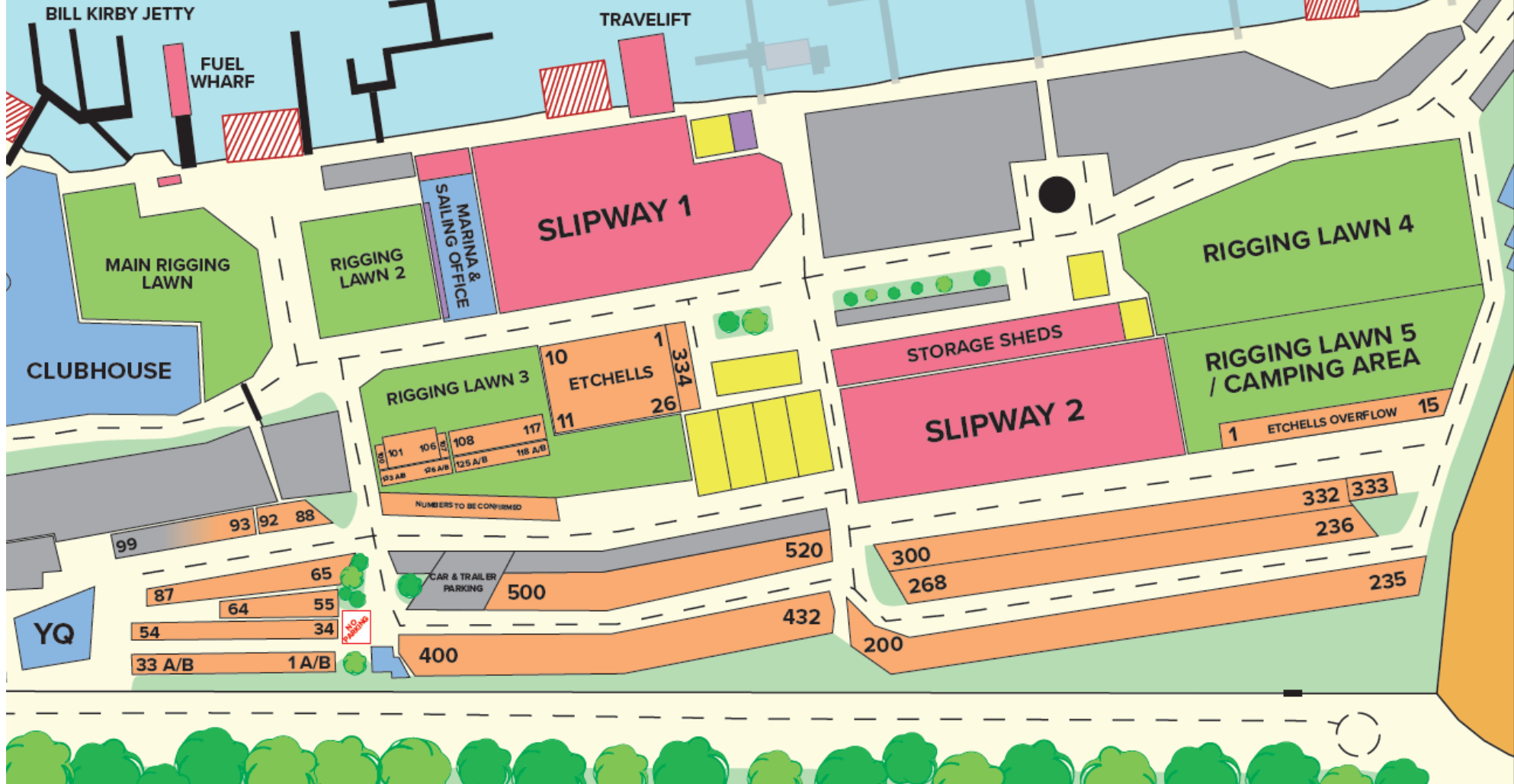
3. BEHAVIOUR AND CONDUCT:

- 3.1 Where applicable the RQYS House Rules and further RQYS policies apply especially in regard to Conduct, Juveniles, Under Age Drinking, Responsible Service of Alcohol and Code of Behaviour.
- 3.2 Young children are to be supervised by a parent or guardian at all times. RQYS operates a slipway and has several trades onsite, and for safety reasons, children must be supervised at all times by a responsible adult.
