9. EQUIPMENT INSPECTION

DELETE 9.1, 9.2, 9.3 & 9.5

- 9.1 All boats must pass Equipment Inspection before being eligible to race.
- 9.2 Each boat shall produce or verify the existence of a valid measurement certificate.
- 9.3 All boats shall undergo inspection of hulls, spars and sails as well as equipment checks according to the OKDIA Class Rules (including Section E of 'OKDIA Major Championship Event Manual") unless otherwise decided by the OKDIA Chief Measurer. All inspected equipment will be identified for the Championship. Only identified equipment may be used during the championship.
- 9.5 Equipment checks may be made throughout the regatta at the discretion of the Technical Committee, Race Committee or the International Jury.

- 9.1 This regatta is an international event for the purpose of RRS G1.1
- 9.2 A Technical Committee shall be appointed in accordance with RRS 92.
- 9.3 Boats shall be available for inspection in accordance with Notice of Race schedule.
- 9.5 The procedures for inspections will be specified in the ER.

18. INSURANCE

DELETE 18.1

18.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10,000,000AUD per incident or the equivalent.
